**Please take time to read the following information.**

**Safety & Risk**

A first aid area will be situated near the start & finish lines and throughout the course of the Community ride for Life. Should a cyclist/walkers feel unwell or unable to go on or be injured they should make their way to the first aid area.

However, please note that the *Community Rescue Ride for Life™* cannot guarantee your safety. Please acknowledge this by signing the Agreement Waiver Indemnity. Also note that this is a mandatory demand of the event. Possible risks include collisions with other cyclists, and or pedestrians or animals that may have wandered onto the course.

Cyclists/walkers enter at their own risk, are responsible for their own physical condition and are urged to train and have a medical check up before the competition. A cyclist deemed unable to complete the course may be asked to exit from the circuit.

**Agreement Waiver & Indemnity**

In consideration of acceptance of my entry in the *Community Rescue Ride for Life™* (Hereafter called the Event).

I have signed for myself, my heirs, executors & administrators & agree with each of the Indemnified Parties (as defined herein and declare that:

1. I hereby waive release and discharge all and every claim, right or cause of action for which I might have or which arises out of my death, injury, result of my participation in the Event EXCEPT to the extent that such may be proven to have been caused by the wilful act or omission of any one or more of parties hereinafter referred to as the indemnified parties.
2. This waiver release and discharge shall operate jointly and severally in favour of the Indemnified Parties, namely: *Community Rescue Ride for Life™*, Dynamique Events & Public Relations, sponsors, supporters, Maroochy Council, persons, corporations, contractors, subcontractors, volunteers, servants and employees involved or otherwise engaged in promoting, staging, administering, running or controlling the Event.

3. I agree to indemnify and keep indemnified parties against all actions, suits, demands, claims, proceedings, costs, expenses, liabilities and judgements (Including the negligence, breach of contract or breach of statute) arising out of or in relation to my/our participation in the Event. This indemnity may be pleaded as a bar to any action, claim, demand, suit or legal proceedings.
4. I consent to receive such medical aid or preventative treatment which may be deemed advisable in the discretion of Event Medical Officials in the event of any injury accident or illness to me as the result of my participation in the Event.
5. I consent to the free use of my name or photograph in any newspaper, promotional, advertising material, video or telecast in connection with the Event and/or its partners.
6. I affirm that I have properly trained for and am fully satisfied as to my physical & medical condition to compete in the Event.
7. I agree to abide by & accept the rules & regulations of the Event and to accept the decisions of the race committee.

**Indemnity in respect of persons under 18 years**

In consideration of the *Community Rescue Ride for Life™* agreeing to my/our request to accept the applicant entry of the minor applicant, I agree for myself, my heirs, executors and administrators to indemnify and keep indemnified the Indemnified Parties against all actions, suits, claims, proceedings, demand costs, expenses, liabilities or judgements which the applicant and I may have against the Indemnified parties but for the terms of this agreement in respect of any death, injury, damage, loss or loss sustained by the applicant's participation in the Event. I affirm that I have full authority on behalf of both Parents and/or Guardian to sign the Indemnity & that this indemnity may be pleaded as a bar to any claim demand or suit to legal proceedings.
